**AMENDED  
JUDGMENT  
No Probation**

On April 13, 2007, came the attorneys for the State, Prosecuting Attorney James Kanatzar and Assistant Prosecuting Attorneys Ted Hunt, Dan Miller and Robin Sipe. Defendant appears in person and by counsel, Thomas Jacquinet and Susan Elliott.

**IT IS ADJUDGED** that Defendant having been found guilty upon a verdict entered on March 16, 2007, is guilty of the offenses of:

- Count IV - Murder 1<sup>st</sup> Degree, a class "A" felony, of Catherine Barry,
- Count V – Murder 1<sup>st</sup> Degree, a class "A" felony, of Naomi Kelly,
- Count VII – Murder 1<sup>st</sup> Degree, a class "A" felony, of Ann Barnes,
- Count VIII – Murder 1<sup>st</sup> Degree, a class "A" felony, of Kellie Ford,
- Count X – Murder 1<sup>st</sup> Degree, a class "A" felony, of Sheila Ingold,
- Count XI – Murder 1<sup>st</sup> Degree, a class "A" felony, of Carmeline Hibbs.

The Court having informed the defendant of the verdict and the findings of guilt made by the Court, asks defendant whether or not there is any legal cause why judgment and sentence should not be pronounced. The defendant offers none. Therefore the Court proceeds with sentencing.

**IT IS ORDERED AND ADJUDGED** that Defendant is sentenced to the custody of the Missouri Division of Adult Institutions:

Count IV - Murder 1<sup>st</sup> Degree - Life without the possibility of parole;

Count V - Murder 1<sup>st</sup> Degree - Life without the possibility of parole;

Count VII - Murder 1<sup>st</sup> Degree - Life without the possibility of parole

Count VIII - Murder 1<sup>st</sup> Degree - Life without the possibility of parole

Count X - Murder 1<sup>st</sup> Degree - Life without the possibility of parole

Count XI - Murder 1<sup>st</sup> Degree - Life without the possibility of parole.

Said sentences shall run **consecutively** with each other.

**IT IS ORDERED** that the Court Administrator deliver a copy of this judgment and commitment to the Jackson County Department of Corrections and that the copy serve as the commitment of the Defendant. **Defendant is to remain at the Jackson County Department of Corrections until Monday April 16, 2007.**

**IT IS ORDERED AND ADJUDGED** that the State of Missouri have and recover from the Defendant the sum of **\$68.00** for the Crime Victim's Compensation Fund. Further, Defendant shall all pay court costs and/or restitution, as deemed necessary.

Defendant has been advised of his rights pursuant to Missouri Supreme Court Rule 29.15.

**The Court finds that Defendant has been adequately and effectively assisted by counsel.**
