On May 26, 2012 at approximately 0023 Deputies from the Harford County Sheriff's Office responded to 535 Terrapin Terrace for a report of a missing person. A subsequent investigation revealed that a Mr. Kujoe Bonsafo Agyei-Kodie had left the home on May 25, 2012 at 0530 Hrs dressed in shorts and T-Shirt and was reported to be preparing to jog. Mr. Kodie left all of his personal effects in the home to include his wallet, cell phone and identification. Mr. Kodie did not return to the house from the jog.

On May 26, 2012 Det. Hall assigned to the Criminal Investigations Division of the Harford County Sheriff's Office was assigned the initial investigation. Det. Hall began contacting local detention centers and hospitals. He was met with negative results. Det. Hall conducted numerous interviews with individuals who knew Mr. Kodie personally. All of these individuals reported that they had no contact with Mr. Kodie.

On May 29, 2012 Detective Lane was assigned this investigation and began by contacting the residents at 535 Terrapin Terrace. Detective Lane was advised that Mr. Kodie had not returned and no further information could be provided. Detective Lane provided the adult residents of the home with his contact information and requested that if any additional information could be learned that they contact Detective Lane.

On May 29, 2012 at approximately 2230 hrs Detective Lane was contacted by Mr. Antony Kinyua. Mr. Kinyua reported that his son Jarrod Kinyua located what he believed to be human remains in the basement of the home. Detective Lane responded to the home and spoke with Jarrod Kinyua who reported that he entered the laundry room of the home and observed a blanket thrown on top of a box. Upon removing the blanket he observed two metal tins. Mr. Kinyua reported that he opened the tins and observed a human head and two human hands. Mr. Jarrod Kinyua reported that he then confronted his brother who denied the remains were human and stated that they

were animal remains. Mr. Jarrod Kinyua then responded to the main floor of the home and requested his father accompany him to the basement. Upon returning to the basement Jarrod Kinyua observed that the items he observed were gone and that Alex Kinyua was cleaning the container he observed them in.

Detective Lane and Peter's then obtained a search and seizure warrant for the location 535 Terrapin Terrace Joppa MD 21085. During this search human remains were recovered on the main floor of the home specifically a human head and two hands. An interview was conducted with Mr. Alex Kinyua were reported that he had caused the death of of Mr. Kodie by cutting him up with a knife. Mr. Kinyua further reported that after causing the death he had ingested Mt. Kodie heart and portions of his brain. Mr. Kinyua then directed Detectives to 536 Trimble Rd the Town Baptist Church and stated the remainder of Mr. Kodies body could be located in a dumpster on the property. Detectives Lane and Peters requested that this area be canvassed and the above described remains were located.

All of the events occurred in Harford County, State of Maryland.
